

Dunfermline & District Motor Cycle Club AGM 2007

Minutes of meeting held 23rd January 2008 at the Queensferry Hotel, North Queensferry

Welcome and apologies

Willie Gillespie welcomed 26 members to the meeting. Apologies were received from Linda who was ill and from Bob Malloch who was on a work-related course.

Chairman's report

Willie Gillespie outlined the Club's activity for 2007 (a summary of which forms much of the Secretary's Report). The 1st SACU Support Championship event of 2008 will be held, by us, at Dunduff. The John Davies Memorial Adult Championship trial will also be at Dunduff. A snack van is provisionally booked to attend both events. The other Adult Championship event will be at Callander. Willie commended those members who competed in the SACU Championships and the SSDT and congratulated them on their success. Good luck to all our members who are competing in this year's SSDT in May.

Unusually, no formal committee meetings were held this year but regular contact and consultation between committee members has resulted in a successful year for the Club regardless! In fact, Willie wished the Club as good a year in 2008 as we experienced in 2007.

Minutes

The minutes of the 2006 AGM, held 24/1/07, were made available for those attending to read. Willie Gillespie proposed their adoption, seconded by Stephen Baird.

Secretary's Report – compiled by Stevie Baird/read by Russell Whiteford

Club membership for 2007 stood at 93 which is roughly the same as for the previous 4 years.

In 2007 we planned to hold 6 Club trials, 4 Nationals and the Jimmy Adamson Memorial tuition trial.

Unfortunately due to flooding at Sandy Cook's Milnathort farm we lost a Club and a National event in early March. In August another Club round was lost due to Foot and Mouth precautions. The Club Championship awards being presented tonight are therefore based on the results for 4 rounds.

Last July saw the first running of the John Davies Memorial Trial which was a Round of the SACU Adult Championship and was held at Dunduff. The trial was a great tribute to Johnny, and Ann did a lot of work behind the scenes organising a Winner's trophy as well as commemorative t-shirts for all the riders and officials.

The best club members in SACU national trials in 2007 were Wull Gillespie in 3rd place and Crawford Carrick-Anderson 4th in the Adult Championship. In the Clubman class Stevie Baird came 3rd with Scott Taylor 4th. A fine achievement for yourselves and the Club.

At the Scottish Six Days Trial Crawford Carrick-Anderson just missed out on a special first class award by 1 dab. Neil Dawson, Ian Shedden, Wull Gillespie and Grant Adamson also received a first class award. Andy Muir received a 2nd class award.

Perth & District held the annual team trial at Monzie in October and Dunfermline Club were well represented by 5 teams. Winners of the event were our Adult A team comprising Neil Dawson, Wull Gillespie, Jim Tennant and Stevie Baird. Our Over 40 team of Allan Adamson, Dougie Bald, Russell Whiteford and John Garrioch came 2nd in their class. Well done to everyone who took part and represented our Club. It was particularly pleasing to see Grant Adamson back riding after his serious mountain bike accident in July. He seems to have made a good recovery and the Club continue to wish him well.

Another guy sampling hospital food this year was Willie Gillespie. As many of you know, Willie had a hip replacement on Guy Fawkes' day and he's making good progress to a full recovery. We have identified the reason for Willie's premature hip failure – too much dabbling!

Allan Adamson ventured south of the border in October to compete in his first Scott trial for over 10 years on his 160 Scorpa. Allan finished 2 hours 16 minutes behind winner Dougie Lampkin which is a great achievement and particularly on a small-engined bike. He even managed to get his photo in the Trial Magazine. Well done Allan.

Others travelling far afield last year were Neil and Joe Dawson, Joe did most of the British National Youth D trials and did very well coming 4th.

For 2008, the SACU have decided to reduce the number of Youth/Over 40 Rounds and each club may hold only one event. This has been applied for, alongwith 2 Adult Championship rounds and the dates for these can be found on the Trials Planner on the website.

The Club is once again well represented at the SSDT with Neil Dawson, Grant Adamson, Stevie Baird and Crawford Carrick-Anderson.

The website (www.dunfermlinemcc.co.uk) is doing well with 7026 visits between January 2007 and January 2008 – an average of 19.14 per day. The most visits in one single day was 59 which was on Monday 23rd July, the day after the JD memorial trial.
